

#### **Dr Helena Thornton**

#### **Screening for Mental Disorder**

I qualified at Birmingham University in 1978, and moved to Manchester in 1980, and joined General Practice as a principal in 1981.

In 1995 I responded to an invitation to find out more about St Mary's Sexual Assault Referral Centre, became inspired by Dr Raine Roberts and Dr Vicky Evans, and joined the team. I have worked there ever since. I retired from General Practice in 2017, but continue to work at St Mary's Centre.

I took the Diploma in Medical Jurisprudence in 1999, and was a Founder Member of the Faculty. I was an examiner for the DFCASA (Diploma in Forensic and Clinical aspects of sexual assault), run with the Society of Apothecaries, and then became an examiner for the FFLM exams in 2008. I was the Chief Examiner from 2013 to 2018, and became the Registrar in May 2020. I am involved in teaching and training in Manchester.

I am passionate about providing excellent care to complainants of sexual assaults of all ages, and about maintaining standards in forensic medicine generally.

I live in Saddleworth with my husband and three very spoilt cats, and when not working I am learning to play the saxophone.

#### Professor Rajan (Taj) Nathan



Consultant Forensic Psychiatrist & Director of Research, Cheshire and Wirral Partnership

#### Assessment of ASD/Neurodiversity in Detainees

Professor Nathan is a Consultant Forensic Psychiatrist and Director of Research (Cheshire and Wirral Partnership NHS Foundation Trust), Honorary Senior Research Fellow (University of Liverpool), Visiting Professor (University of Chester), Adjunct Professor (Liverpool John Moores University), and CRN-NWC Clinical Lead and Mental Health Specialty Lead (National Institute for Health Research).

Professor Nathan has extensive experience of working in a wide variety of forensic and non-forensic mental health settings, particularly in the context of complex mental health problems, personality disorder and autism spectrum disorder.

As well as his day-to-day clinical work, he has provided advice on cases across a national footprint and has contributed to national policy initiatives. Professor Nathan has undertaken postgraduate study at the Universities of Oxford, Liverpool and Leeds and he has conducted research including in the areas of standardized assessments, personality disorder, violence, clinical decisionmaking and risk.

Professor Nathan is also regularly called to provide independent expert opinion to courts across the country. More recently he has been involved in the public dissemination of forensic psychiatric topics, with the release of his book (Dangerous Minds: A Forensic Psychiatrist's Quest to Understand Violence, 2021), publication of his work in The Guardian and The Spectator, and radio/TV documentary work.

#### Update on Acute Behavioural Disturbance De-escalation

Keith Rix's involvement in the forensic field began in the 1960's when he lived in hostels in London with ex-offenders and assessed prisoners for hostel admission. Whilst a senior lecturer in psychiatry in Leeds he became a visiting consultant psychiatrist at HM Prison, Leeds, and established the Leeds Magistrates' Court Mental Health Assessment and Diversion Scheme and the city's forensic psychiatry service. He has provided expert evidence to courts and tribunals for almost 40 years, including on a pro bono basis in capital cases in the Caribbean and Africa. He is the editor of A Handbook for Trainee Psychiatrists and co-editor of Rix's Expert Psychiatric Evidence. He is Visiting Professor of Medical Jurisprudence, University of Chester, Honorary Consultant Forensic Psychiatrist, Norfolk and Suffolk NHS Foundation Trust and Mental Health and Intellectual Disability Lead, Faculty of Forensic & Legal Medicine of the Royal College of Physicians.


