1.2 AIMS AND SCOPE

Official journal of the Faculty of Legal and Forensic Medicine.

The Journal of Forensic and Legal Medicine publishes topical articles on all aspects of legal medicine. The medical principles of care and forensic assessment of living individuals, whether adult or child, in contact with the judicial system are examined and the Journal has a broad international perspective.

Topics covered in the journal include the following, particularly with relevance to the clinical setting:


forensic medicine and psychiatry, including child abuse and neglect, interpersonal violence, elder abuse, domestic violence, sexual violence, suicidal behaviours, care in custody, restraint injuries, torture, and human rights;
forensic pathology, death investigation and causes of death, including death in custody and suicide;
forensic science, including the forensic aspects of toxicology, anthropology, and odontology.

All submitted manuscripts are reviewed initially by a JFLM editor. Manuscripts are evaluated according to the following criteria: material is original and timely, writing is clear, primary and secondary objectives are explicitly stated, study methods are appropriate and described so that they can be understood and reproducible, data are valid, conclusions are reasonable and supported by the data, information is important, and topic is clinically relevant in forensic medicine. From these basic criteria, the editors assess a paper's eligibility for publication. Manuscripts with insufficient priority for publication are rejected promptly. Other manuscripts are sent to expert consultants for peer review.

2 QUALITY / CONTENT DEVELOPMENT

2.1 IMPACT FACTOR

The Impact Factor measures the average number of citations received in a particular year by papers published in the journal during the two preceding years (Regd. Thomson Reuters Journal Citation Reports).



2.2.1 Number of citations






3 MANUSCRIPT FLOW




The Rejection Rate shows the number of rejected articles as a percentage of the sum of rejected and accepted papers.




3.2 GEOGRAPHICAL BREAKDOWN OF ACCEPTED ARTICLES

AFR = Africa; ASIA = Asia; OCE = Oceania; EU = Europe; LAC = Latin America & Caribbean; NA = North America




4 SPEED

4.1 AVERAGE EDITORIAL SPEED FOR ALL SUBMITTED MANUSCRIPTS

First Decision: is the time taken by the editor(s) on the basis of a first peer review. If more than one review is carried out, the date of the last returned is taken.

Total Author revision time: Time the author takes to revise his/her article on the basis of comments made by the reviewers(s). If there are several rounds of revisions, these are all added up to calculate the total revision time.

Final disposition: Final Decision taken by the editor on the basis of a first peer review. If more than one review is carried out, the date of the last returned is taken.




4.3 PUBLICATION SPEED

Publication (printed issue): average total time from submission of an article to despatch of the issue containing that article from the warehouse.





5.1.1 ScienceDirect average Vol/Issue usage. Last 3 years plus YTD


