

1. Editor's Message

In January 2022, I became the new Editor-in-Chief. I'm pleased to inform you that the journal is doing well. The progress that has been made in recent years is continued.

Within this report, we lay out a number of metrics, datasets, and information which provide specific detail to this, but in summary:

- The total number of submissions for 2021: 605
(We have received 752 submissions for 2020, but we have seen huge growth of submissions across all subject areas due to COVID and this is a normal decrease).
- The overall rejection rate for 2021 was 79% (82% for 2020). We have published around the same number of papers in previous years.
- The speed for handling submission is on average 6.4 weeks to make a final decision, which is within the 90 days window.
- Our CiteScore is on track to increase from 2.5 to 2.9, receiving 233 total citations for 2021.
- Over 270,000 downloads were achieved.

In addition to this, I am really pleased to see that our most cited, downloaded and social-media active articles cover a broad range of topics and sub-disciplines, which reflects the broad appeal of the Journal as well as the membership of the Faculty.

My Associate Editors (Maria) and I will continue our efforts over this year, working with our Elsevier colleagues (Katie and Annapoorni), to further enhance the Journal. In May, two new associate editors will join our team: Wendy Birch and René Gapert.

We are discussing the development of a couple of special issues. The Alcimedes reviews will be continued. I will join you all in person at the General Assembly in May.

As ever, I am always happy to discuss the Journal with Faculty members, and welcome suggestions and ideas for initiatives and special issues. On behalf of the JFLM team, I thank you for your continued support and I hope you are all safe and well.








3.2. Submitted Articles by Country & Region

3.3. Accepted Articles by Country & Region








