

### FFLM Strategy for 2022/23

The FFLM has the following charitable objectives:

- To promote for the public benefit the advancement of education and knowledge in the field of forensic and legal medicine in all its classes;
- To develop and maintain for the public benefit the good practice of forensic and legal medicine by ensuring the highest professional standards of competence and ethical integrity.

The strategy for 2022/23 will continue to ensure that:

- We will support our members recognising that they are our most important asset.
  We are continuing in our campaign for specialty status, recognising that this is important to all our members. We will encourage the involvement of international members and we will encourage the involvement of Allied Health Professionals.
- 2. We will maintain and further develop our quality standards along with our library of educational resources.
- 3. We will continue to develop partnerships with other agencies and work with them to promote high quality care.
- 4. We will continue to act as the leading resource in the field of Forensic & Legal Medicine.

### 1. We will support our members recognising that they are our most important asset

### Membership engagement

- Maintenance of weekly Bulletin
- Annual survey of members with results shared with members (available online <u>here</u>)
- Option to attend the Annual General Meeting either in person or virtually
- Efficient monitoring of the generic email with timely responses to members' queries and those from external agencies
- Continuation of Member rates for webinars, development training courses (DTCs), and the annual conference. 10% discount applied to the rate for DTCs for both members and non-members
- Encouragement of international members to become more widely involved with the Faculty
- Introduction of an Appraiser Forum to support appraisers who often work outside of organisations with clinical governance processes
- Introduction of an Adult Safeguarding Forum to share professional experience and provide time for discussion of cases in a relaxed environment
- Option to join the Medical Expert Witness mailing list (electronic newsletter circulated by the FFLM's Medical Expert Witness Lead)

# Increase membership through diversification (from the core groups of dentists, doctors, nurses, and paramedics)

- Clinicians working in secure and detained settings membership route opened on 01 August 2021
- DVLA clinicians permitted to join as Affiliates from July 2022 onwards
- Investigating Membership by Equivalent Qualification for Radiologists involved in postmortem imaging
- 16 applications received for the route to LFFLM (SOM) [c] via prescribed/equivalent experience (three of whom are now FFLM Licentiates)
- Introduction of post nominal AFFLM (DLM) or Assoc (DLM) for successful DLM (and Part 1 MFFLM) candidates who obtain a Distinction in their examination

### **Journal of Forensic & Legal Medicine (JFLM)**

- Journal is flourishing. Article submission and rejection rate remain steady. Journal CiteScore is on track to increase
- Student Affiliates granted online access to the JFLM

### Website

 New website runs well and has increased functionality e.g. attendees are automatically emailed their reflections after completing educational activities

### **Suitable Person & Appraisers**

- FFLM Members can connect to a GMC appointed Suitable Person
- Anonymised yearly report provided by Suitable Person to Faculty Board
- Access to list of Appraisers

# 2. We will maintain and further develop our quality standards along with our library of educational resources

### **Quality standards and educational resources**

- Educational documents most important resource for members and the FFLM (Nationally and Internationally) as confirmed in the membership surveys
- Distribution list for educational documents checked and amended, regularly updated and added to, with a programme of circulation of the new educational documents after each Academic Committee
- Publication of guidelines and supporting documents for those who involved in the assessment of individuals exposed to a Controlled Energy Device (CED). Developed with the College of Paramedics, National Police Chiefs' Council, Royal College of Emergency Medicine, Royal College of Nursing and United Kingdom Association of Nurses & Paramedics
- Hybrid proposal developed to produce General Forensic Medicine (GFM) content for the FFLM/Ulster University e-learning course. Recorded sessions with summary tables/mind maps to be created
- Continuation of webinar programme with the aim of one free webinar a month for FFLM members. 12 free webinars have been held since July 2021
- DTCs adapted and moved online due to COVID pandemic. Adult Safeguarding DTC was free for FFLM Members to attend due to sponsorship by NHSE&I
- Development and facilitation of the Forensic Aspects of Adult Safeguarding workshops for level 4 Clinicians (sponsored by NHSE&I)
- Funding from NHSE&I secured to develop and deliver train the trainer and general forensic awareness sessions, along with the development of the FFLM Adult Safeguarding forum and FFLM website resources
- Continuation of the FFLM/Teesside University (TU) Course in GFM (leading to the University Certificate in Postgraduate Professional Development (UCPPD))
- Appointment of a Lead Facilitator for Sexual Offence Medicine (SOM) Dr Leanne Tee
- Liaison with TU regarding the development of apprenticeship programmes for GFM and SOM
- National roll out of CED Clinician Assessment Training Course. Over 40 courses delivered and over 300 clinicians trained
- FFLM members involved in the revision of the *Physical signs of child sexual abuse evidence-based review* i.e. the 'Purple Book'
- Continued access to the Royal College of Physicians Library and Information Centre
- Establishment of Assisted Dying Working Group (issue to be revisited in 2024)
- Re-stablished the FFLM Research Subcommittee
- Introduction of SR Johnson prize for medical undergraduate students

### **Promotion of examinations**

- The DLM and Part 1 MFFLM/LFFLM examinations are now held online
- Scenesafe provide a prize of £250 to the candidate with the top mark for the Part 1 MFFLM/DLM exam in 2021, 2022, 2023 and 2024
- Hybrid model for the Part 2 MFFLM/LFFLM GFM and SOM (developed in response to the COVID pandemic) to continue. This allows candidates to complete the written portion of the examination and some of the OSCEs online in March. Remaining OSCEs completed face to face in June in London
- Promotion of the DLM examination outside of core groups (legal advisors, paralegals, etc.)
- New format of the Part 2 Membership examination for DLAs and MLAs agreed and to be developed

## Specialty status application

 Progress continues on the application for specialist status. A Freedom of Information Act request has been submitted to ascertain why the application has not been supported by UKMERG/COPMeD. (Timeline of the application can be viewed <a href="here">here</a>)

### **FFLM Finances**

We continue to carefully monitor the FFLM finances - they are under constant review following the fundamental changes required to reduce costs authorised by the Faculty Board in July 2019. We:

- Continue to make reductions in costs wherever possible e.g. editing FFLM guidance documents internally, virtual meetings for FFLM committees, virtual office for FFLM office staff, electronic storage of documents etc.
- Look to increase income through alternate routes e.g. fees for including job adverts in the FFLM Bulletin.
