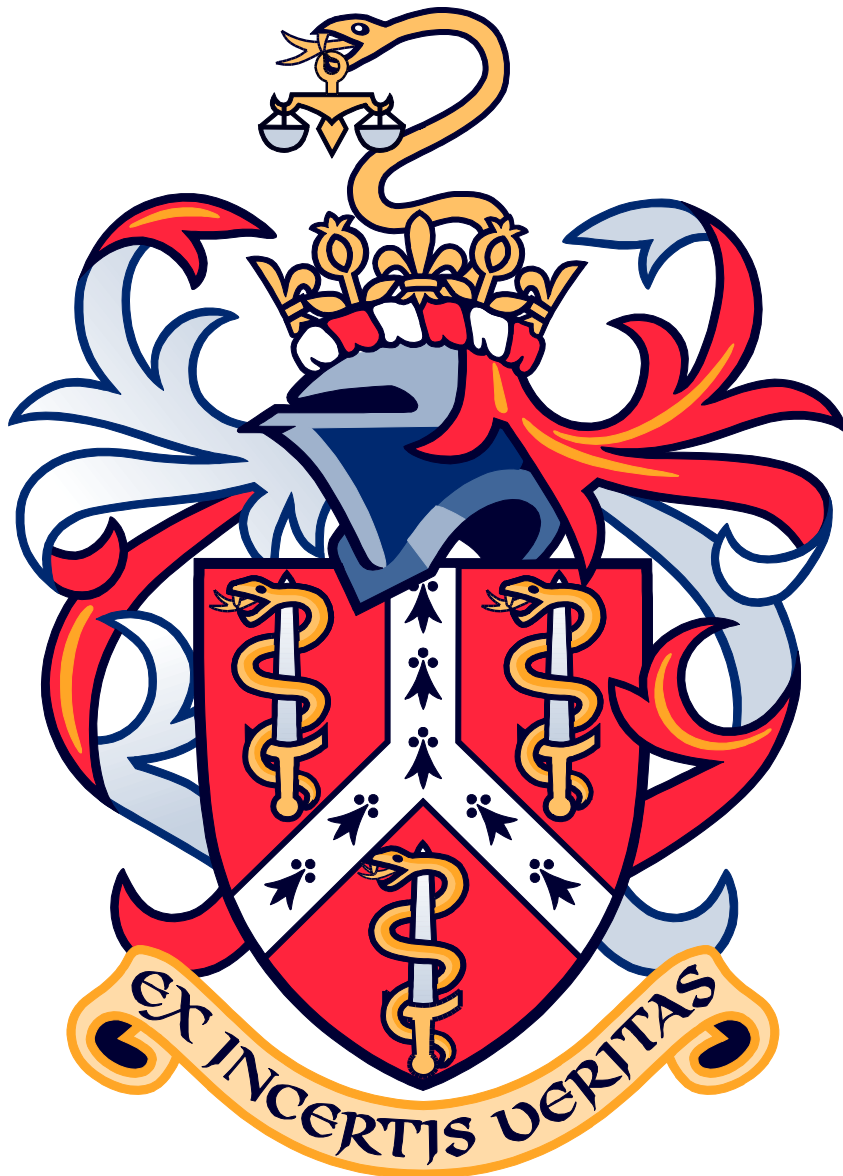

Introduction / The ED Experience: Common Road Traffic Issues

Dr Will Anderson is the Forensic Clinical Lead for Partnering Health Limited (PHL) and covers the Hampshire and City of London contracts. He has been a full-time FME for 17 years, having moved away from being a Neurosurgery Registrar after realising that training to be a Brain Surgeon wasn't as glamorous as it sounded!

His particular interests are medical photography of injuries, and road traffic legislation. He is the lead author of the Photography in Custody and SARC's (PICS) document from 2017 and 2019 (third edition due to be published shortly), and was also the lead author on the first two editions of the FFLM Drug-Driving Competencies document.

The Link Between Criminality and KSI's

Marc has been a police officer in Sussex for just over 26 years starting his career as a probationer in the seaside town of Bognor Regis in 1997.

After a short period of time in response policing Marc followed his passion and joined traffic at Shoreham and spent the next 10 years progressing to Inspector whilst gaining a range skills and experience in Roads Policing.

Since then, he has worked in a variety of different roles across the force but has always been drawn back to Operational Policing recently being involved in the Sussex response to Covid and prior to his current role as the Gatwick Airport Commander and Head of Firearms for Surrey and Sussex.

Marc joined the National Roads Policing portfolio in April this year as the head of the Operations, Intelligence and Investigations working group, his primary objective being to work with others to deliver the National Roads Policing Strategy at a tactical level. Alongside this he maintains his involvement in operational Policing as part of the gold cadre in Sussex.

Outside of work to maintain fitness and obtain his regular adrenalin fix Marc will often be found riding his bike on the South Downs or when most people are sheltering indoors from the storm, he will be windsurfing off the south coast!

Prof Denis Cusack



Professor and Director, Forensic & Legal Medicine, Medical Bureau of Road Safety, University College, Dublin, Ireland

Denis Cusack qualified as a medical doctor from University College Dublin, Ireland (1980) and trained in postgraduate clinical medicine in General Internal Medicine & Diabetes/Endocrinology in hospitals in Ireland and Boston, Massachusetts, USA (1986-1987). He then qualified as Barrister-at-Law from the Kings Inns, Dublin (1991) and practised in the Irish Courts as Barrister (Advocate), particularly in the area of medical and healthcare law (1991-1998). He continued in clinical practice in Internal Medicine and developed and continued professional medical specialty practice and training in Forensic and Legal Medicine. He is currently Director (Head) of the Medical Bureau of Road Safety, the national forensic intoxicant laboratory for Ireland (1997 to date). He was Lecturer and then Full Professor of Forensic & Legal Medicine at the School of Medicine, University College Dublin (1992-2017) and at Penang Medical College, Malaysia (2000-2017) and remains as Full Professor Emeritus of Forensic & Legal Medicine at UCD involved in postgraduate teaching and research. He has served in the in the National Coroner Service of Ireland (Death Investigation System) since 1992 as Coroner/Senior Coroner for the District of Kildare in Ireland (1995-2022), Deputy Coroner for Dublin City (1992-1996) and now as Deputy Coroner for County Clare (2023).

He serves presently as President of the European Council of Legal Medicine (of 34 European countries) and as Vice-President and Member of the Presidium of the International Academy of Legal Medicine (a worldwide body). He is Founding Consultant Editor of the Medico-Legal Journal of Ireland (1995-2022); a Past President of the Coroners Society of Ireland (2008-2010); and Past President of the Medico-Legal Society of Ireland (2015-2017). He is a Member of the Scientific Advisory Board at the International Criminal Court and of the Board of the International Council on Alcohol, Drugs and Traffic Safety and also serves on a number of other expert committees. He is an International Assessor for Medicine Programmes, Portuguese Agency for Assessment and Accreditation of Higher Education. He is reviewer for a number of international forensic and other medical journals. His Specialist and research interests and publications include forensic medicine, forensic death investigation, intoxicated driving, road traffic medicine, medico-legal issues in healthcare practice and medical ethics and professionalism. The ED Experience: Common Road Traffic Issues

Jon is an operational serving Police Officer with the Operations Roads Policing Team at Devon and Cornwall Police, having initially joined Hampshire Constabulary in 1997 before transferring in 2018. He has been actively involved with Preliminary Impairment Testing within the UK since its inception in 1999 and is recognised by the College of Policing as a Subject Matter Expert for Drink and Drug Driving supporting the amendments of the Roads Policing Curriculum.

He is a certified Drug Recognition Expert Instructor having met the international standards for recertification bi-yearly since 2004. He instructs law enforcement officers in both the UK and US to detect person under the influence of drugs and in identifying the category or categories of drugs causing the impairment. He co-writes the manual of guidance form series for Drink / Drug Driving (MG DD), an instructor trainer for DTech international for Preliminary Drug Testing devices (DrugWipe3S), lead investigator for Killed and Serious Injury collision investigations and Tactical Advisor for Pursuit and Risk management.
