Academic Dean's Report 2023 – 24

Introduction

This is my first report as Academic Dean and it's been a busy, interesting year, not to mention a steep learning curve. It has been an honour to take on the role and I have enjoyed getting to know and work alongside some remarkable individuals who strive so tirelessly to promote standards in forensic and legal medicine.

We have a team of dedicated examiners who, under the leadership of the Chief Examiner, Sandy Fielding, and the expertise of Angela Hall, our educational advisor, have facilitated the exams. We are always in need of more examiners, and hope to recruit some nurse examiners, so please let us know if you are interested in becoming an examiner.

The DLM and Part 1 LFFLM and MFFLM were held on-line in October 2023, and the SAQs and on-line OSCEs were held in March, with the final face-to-face OSCEs planned for June. One of the biggest changes this year was planning the move from submission of COVEs and Portfolios to sitting the SAQ and OSCE for Licentiate candidates, commencing the next exam year.

We have commissioned TestReach to run the on-line exams, which has been an investment that we hope will improve the efficiency of the exams. Many thanks to Abi Barlett who led the exams project and worked hard to create a database of exam questions. Sadly, there has been little progress on the proposed dento-legal exams and the future of the medio-legal exams is being discussed through a working group chaired by Prof Sarah Hull, who has been a great support.

Our Secure and Detained settings (SDS) colleagues are in the process of creating exams for SDS and we look forward to launching these in due course.

We are looking to appoint a new Expert Witness Lead and thank Professor Keith Rix for his efforts in this role. Keith sends out an expert witness newsletter which is always informative and thought provoking, if you wish to receive this newsletter, please let one of the office staff know and we can add you to the mailing list. We are hopeful that Keith's replacement will champion the call to regulate expert witnesses.

The opportunity to collaborate with others has been welcomed and we have engaged with the Independent Office for Police Conduct (IOPC) to review and disseminate learning from a death in custody and have co-badged guidance with Royal College of Emergency Medicine (RCEM), Royal College of Psychiatrists (RCPysch) and Royal College of Paediatrics and Child Health (RCPCH), to name a few.

5.4 Overall, the feedback on webinars continues to be positive and we welcome any suggestions for future topics and speakers.

Adult Safeguarding

- 5.5 The Forensic Aspect of Adult Safeguarding Forum, chaired by Dr Elisabeth Alton and Professor Margaret Stark, continues to meet quarterly.
- 5.6 The Virtual Adult Safeguarding Day on 16 April 2024 was very well attended with over 200 participants. Feedback has been very positive with comments such as *Absolutely loved it and thought the quality of speakers was second to none, a really great day very interesting with lots of learning I will share across my organisation.* and great sessions to enhance working knowledge of safeguarding and delivered by several key experts. Funding is hoped to be sourced from NHSE&I for a future conference in 2025.

FFLM/Teesside University (TU) Course in General Forensic Medicine

- 5.7 This course, leading to the TU Certificate in Postgraduate Professional Development has run on two occasions since the last AGM. It is due to run again in July 2024 and October 2024.
- 5.8 The start date for TU's PgCert Advanced Forensic Practitioner Higher Apprenticeship (Custody or Sexual Offences) has been postponed until further notice. We are awaiting further updates from TU.

6. Research Subcommittee

We are delighted that our Research Subcommittee chair will be presenting again at our Annual Conference on *The Role of Counterfactual Causation in the Investigation of Death in Custody*. We hope the subcommittee will have a chance to meet face to face at the Annual Conference as all its meetings so far have been virtual.

8. Less Lethal Weapons Update

8.1 We continue to deliver our Clinician Assessment Training Course nationally. Since the last AGM, 30 courses have been delivered. Over 800 clinicians have now attended this course and feedback continues to be positive. Demand for courses is tailing off now as most providers have trained almost all their staff and are simply keeping up with staff turnover.

8.2 Discussions regarding a train the trainer course are still in progress. There are concerns regarding this as there are benefits in running a single national course e.g. standardisation, cost audit purposes etc. We will keep the membership updated as discussions progress.

9. Other Work

There have been several other areas of activity including the following:

- The Appraiser Forum continues to meet twice a year to support appraisers who
 often work outside of organisations with clinical governance processes.
- Established links with Wessex Appraisal Service who have kindly offered training packages for new and already established appraisers. They can also offer independent appraisals.
- Submitted feedback on the updated National Police Custodial Healthcare Service Specification Framework.
- Participated in a Delphi study which was aimed at reaching a consensus on the criteria for the identification and management of Acute Behavioural Disturbance (ABD).
- Shared learning recommendations with the IOPC following a review of a death in custody.
- Submitted feedback on the revised edition of the 'Physical signs of child sexual abuse - evidence-based review' (also known as the 'Purple Book').
- Responded to the following consultations:
 - ➤ The Office for Health Improvement and Disparities consultation on the draft of the first-ever UK clinical guidelines for alcohol treatment.
 - ➤ The 'Call for Evidence' in relation to the recommendation from the Independent Inquiry into Child Sexual Abuse (IICSA) for mandatory reporting and the further consultation setting out the proposals for creating a mandatory reporting duty;
 - > Forensic Science Code of Practice: Version 2.

10. Conclusion

In summary, it's been a busy, fulfilling year, and I am incredibly grateful for the support and expertise of those I work alongside. To those leaving posts, many thanks for all your time and effort, it has been much appreciated. To those who remain in post, thank you for your continued efforts.
